CALL TO ORDER

APPROVAL OF AGENDA

Commissioner Ryckman moved and Commissioner Gordon seconded to approve the agenda, with the addition of items 9.B- WPPA Carbon Policy Statement and 9.C-Reimann Industrial Center, determining that all agenda items were "1) matters necessary and routine, 2) necessary to respond to the outbreak and current public health emergency" per Governor's Proclamation 20-28.2. Motion passed unanimously.

Items for Discussion

Pasco Processing Center Rail Update- Mr. Hayden and Ms. Reyna presented, a meeting was held on Monday, November 16th between the Port of Pasco and the Pasco Processing Center rail users to discuss the PPC Rail maintenance contracts. Representatives from three of the four affected companies were in attendance, and several options were discussed as to their preference for how the maintenance will be carried out.

The next steps for the Port are to have the track inspected and provide the subsequent report to the users. Port staff and legal counsel will continue to gather information for the potential contract execution options.

WPPA Carbon Policy Statement- Mr. Hayden presented a draft version of the WPPA's Carbon Policy Statement. The final version will be presented to the Board of Trustees for vote at the Annual Meeting.

Reimann Industrial Center Update- Mr. Hayden presented, discussions with a potential buyer are taking place for land in the Reimann Industrial Center.
