

## RESOLUTION NO. 1513

### DECLARATION OF PROPERTY AS SURPLUS AND AUTHORIZATION OF SALE OF LANDS

1. Global Trac, LLC desires to acquire certain real property from the Port of Pasco. The real property is described on the attached Exhibit A.

Global Trac, LLC proposes to purchase said property for the sum of One Hundred Fifty-Seven Thousand Six Hundred Eighty-Seven and 20/100 DOLLARS (\$157,687.20) subject to the provisions of the attached Agreement to Purchase and Sell Real Estate between Global Trac, LLC and the Port of Pasco.

2. THE PORT COMMISSION HEREBY FINDS THAT the sale is in accordance with Resolution No. 1422 pertaining to the comprehensive scheme, and that the use of said property is in the best interests of the constituents of the Port of Pasco, and therefore deem it advisable to sell said lands pursuant to the terms of the attached Agreement to Purchase and Sell Real Estate between Global Trac, LLC and the Port of Pasco.



BEGINNING AT THE NORTHEAST CORNER OF ABOVE SAID PARCEL 2; THENCE SOUTH 40°44'41" EAST ALONG THE WESTERLY RIGHT-OF-WAY LINE OF INDUSTRIAL WAY 52.35 FEET; THENCE SOUTH 49°15'19" WEST 337.89 FEET TO THE A POINT ON THE WESTERLY LINE OF SAID PARCEL; THENCE NORTH 40°44'41" WEST SAID WESTERLY LINE 52.35 FEET TO THE NORTHWESTERLY CORNER OF SAID PARCEL;

THENCE NORTH 49°15'19" EAST ALONG SAID NORTHERLY LINE 337.89 FEET TO THE SAID POINT OF BEGINNING.
