RESOLUTION NO. 1606

A RESOLUTION of the Port of Pasco, superseding resolution 1430, updating regulations relating to the regulation of for hire vehicles operating at the Tri-Cities Airport including the Business and Industrial Parks adjacent thereto (hereinafter referred to as the "Airport").

WHEREAS, municipalities including Port Districts may establish, construct, operate and maintain airports and other air navigation facilities pursuant to RCW 14.08 et seq; and

WHEREAS port districts are authorized to control and regulate all for hire vehicles used for the transportation of passengers operating within its jurisdiction as provided by RCW 43.72.160; and to formulate all regulations applicable to vehicles for hire at the Airport as provided by RCW 53.08.220; and

WHEREAS, the Port of Pasco has held a public hearing on these proposed matters pursuant to the requirements of 53.08.220 R.C.W.; and

WHEREAS, it is necessary that rules and regulations be adopted to provide for the orderly use of for hire vehicles to insure the safety and convenience of passengers, and the protection of the public health, safety and welfare of the users of the Airport and its facilities; and

WHEREAS, the Tri-Cities Airport and the adjacent business and industrial parks set forth in attached plats are within the City of Pasco; and,

WHEREAS the City of Pasco has adopted an ordinance relating to airport parking and traffic as set forth in PMC 10.90; and

WHEREAS, it is the intent of the Port of Pasco to add rules and regulations governing the parking, standing, stopping, and use of for hire vehicles to transport passengers from the Airport consistent with the laws of the State of Washington and the City of Pasco ordinances; and with Port Resolution no 1330 and Port Resolution no 1443;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE PORT OF PASCO that the following provisions shall be applicable to the parking, standing, stopping, driving and use of vehicles for hire within the boundaries of the Tri-Cities Airport:

- 1. For hire vehicles are not to be left unattended at any time.
- There shall be no solicitation, whatsoever, of customers by for hire vehicle drivers.
- Taxis may only park in the taxi zone (for the queue); or short-term parking (scheduled pick-ups). Other for hire vehicles must only use designated areas for pick-up and cannot park for any longer than is necessary to accomplish their pickup.
- 4. No customers shall be turned away due to the distance of the fare.
- 5. City of Pasco operating requirements must be met. A copy of the city issued for hire permit and for hire business license, for each driver operating at the airport, must be submitted to the airport administration office in order to operate on airport property. A copy of company's valid business license is also required. TNC drivers must provide a copy of a City of Pasco endorsed business license.
- 6. Only one taxi per company is allowed to park in the taxi zone.

- 7. Operations on airport property require a valid agreement with the Port of Pasco, Tri-Cities Airport.
- 8. Address or other contact information changes of the for-hire vehicle company must be communicated to the Port of Pasco, Tri-Cities Airport within 10 days of the change.
- 9. Drivers may not loiter in or around the terminal building. Drivers may not lay or nap in or around the terminal building or in the grass areas around the terminal building.
- 10. Drivers or employees may not post or hand out business cards or advertising of any kind anywhere in the airport or on airport property, with the following exceptions:
 - a. Business cards or advertising may be provided to the for-hire vehicle's customer upon request by the customer.
 - b. Formal advertising with the Port's advertising concessionaire is permitted.
- 11. If a for hire company has a pre-scheduled pick up, that for hire company vehicle must wait for the customer in the short-term parking lot.
- 12. Passengers maintain the right to choose what for hire company to use, regardless of which one is first in line. Passengers also have a right to know the fares before entering a for hire vehicle.
- 13. Stopping or parking in a marked lane of travel is prohibited. There will be no double parking allowed at any time.
- 14. The Port reserves the right to suspend or deny the privilege of conducting business at the Airport if it is found that any violation of this agreement has occurred. The denial could be for a set number of days for a specific violation or for a period of time until the for-hire vehicle driver and/or company comes into compliance with the provisions of these regulations and the agreement between the Port of Pasco and the for-hire vehicle company. Instatement of sanction(s) for said violation will commence immediately upon verbal notification by the Port, to be supplemented by an official letter sent by certified mail. This verbal and written notification will specify the details of why the sanction(s) is occurring and what the sanction(s) is. Also, if further violations occur during the sanctioning period, it will result in additional sanctions being added, including the termination of the for-hire driver and/or the for-hire company's agreement to operate at the Airport.
